**Course Learning Objectives:**

- Introduce and familiarize students with the basic concepts and tools of economic evaluation in health services research.
- Provide students with basic knowledge and tools to undertake critical evaluation of published economic evaluations of new drugs, technologies, and other health interventions.
- Provide student with a methodological framework with which to undertake the design of economic evaluation protocols.  
Provide students with an appreciation of the role of economic evaluations in the process of health care resource allocation and health policy making.

**Duties:**

- Marking assignments for the course. The instructor will provide a rubric for marking the assignments.
- Attend some class sessions to support with in class learning.
- Provide course development or course delivery support as needed

**Qualifications:**

- Graduate student with an understanding of the learning objectives for the course from direct education and/or professional experience.
